- 1. Meeting Called to Order by Jo B. Alexander, Chair, at 10:00 A.M.
- 2. Roll Call by Sheila Clark, Secretary a quorum was established.
- 3. Presentations Gay Lynn Schwenk introduced the guest speaker, Viridiana Rivera, Program Manager of Homelessness Prevention Services at SAMMinistries. Ms. Rivera gave an overview of the homelessness prevention services specific to seniors, which unfortunately is ending soon. She stated

that additional funding sources are being sought. Until then, seniors should continue to be referred through their general prevention referral line.

- 4. Public Comment none.
- Consider and Act Upon Approval of the Minutes for June 8, 2018 Jene Liaci made a motion to approve the minutes as written, seconded by Doris Griffin; motion carried.
- 6. Chair's Report Jo B. Alexander, Chair, encouraged all BSAC members who are making attempts to keep up with technology—it can be overwhelming and
- 7. Director's Report Gloria Vasquez, Director of Alamo & Bexar AAA, reported the following:
 - A. Staff Recognitions. Gloria indicated that she would like to make staff recognitions a regular part of her report, just as Ms. Rath does with the AACOG Board of Directors.
 - Cindy Boyum, Bexar Managing Local Ombudsman, received her certification for the successful completion of the Management Development Program from the Governor's Center for Management Development.
 - Paula Wanken, Support Services Coordinator, recently received the "Trailblazer" award from the Independent Cattleman's Association of Texas at their state convention in College Station. She received the award for her volunteer work as reporter for the South Central Texas chapter.
 - B. Grants. Gloria reported that one of the goals for AACOG as a whole is to pursue additional grants whenever possible, to help offset the areas where traditional levels of funding have been flat or reduced. Gloria indicated that she will keep the group apprised of these activities, stating that the following opportunities are in varying levels of consideration:
 - NCOA. National Council on Aging released an RFP for organizations to make application to become a Benefits Enrollment Center (BEC). There is only one BEC in the state of Texas, located in Houston. Much of what a BEC does is work already being done by the AAA and ADRC, to assist individuals in enrolling in benefits programs. AACOG will be applying for this grant, and is due August 29.
 - CNCS. Corporation for National Community Service has extended an invitation to apply for a senior companion program. This is a Senior Demonstration Program which would pair low-income eligible seniors as companions to Veterans. AACOG's AAA program is a great fit for this opportunity as it touches both seniors

- and Veterans, both populations already served by AAA. This would be a three-year program. The application is due August 30.
- San Antonio Area Foundation (SAAF). SAAF Responsive Grant Cycle 2 opportunities included grants for senior programming. This year, the senior funding was delayed a month from the rest of the Cycle 2 funding to allow a more-focused approach in alignment with the SALSA Initiative (Successful Aging & Living in San Antonio) goals, being established by the SALSA workgroups and steering committee. That grant cycle opens August 20 with a deadline of September 21. AAA plans to explore that opportunity to determine how best to proceed.
- C. Client Database. Texas HHSC is moving forward with the statewide transition to RTZ, a new platform for managing client information.
- D. ADRC. The Alamo Service Connection is the AACOG region's Aging and Disability Resource Center (ADRC). To promote a greater understanding of who "Alamo Service Connection" is and what the "ADRC" does, efforts are underway for rebranding. This will include a new logo and some potential new marketing.
- E. Walk to End Alzheimer's. AACOG and the Area Agencies on Aging, specifically, has a team being led by Paula Wanken, to help promote awareness of and raise money for the Alzheimer's Association. This disease impacts so many lives and is a major factor in the lives of so many of AAA clients. The walk will be held October 20 at Palo Alto College. Anyone interested in joining the team or donating to TEAM AACOG should contact Paula Wanken.
- F. AACOG Customer Satisfaction Survey. AACOG has launched a customer satisfaction survey to better understand areas of weakness, as well as areas where AACOG is excelling. Everyone is encouraged to complete this survey online. Postcard copies of the survey were made available to everyone. This postcard style is also available at the reception desk at AACOG.

- A. Access and Assistance. Jim Jonson reported on behalf of Marion Thomas, Chair. The subcommittee has not met sine the 2018 Elder Fraud Summit, held Wednesday, June 6. The next meeting will be August 27.

C. Family Caregiver Support. Dianne Teran reported on behalf of Ryan McGuire, Chair. She reported that, thanks to the huge success of the Naomi Feil Validation Workshop held on May 24, at San Antonio College, the Validation Institute is interested in possibly bringing a class to San Antonio for family caregivers. This would be a class of 6- to 9-week sessions. Dianne also reported on upcoming Stress Busters class to be offered for chronic diseases, not just the dementia-related caregivers.

The Coalition is also considering the creation of a quarterly newsletter which would help get the word out about caregiver events, and information, in a more orderly way.

- E. Information, Special Events. Cynthia Romo, Chair, announced the details of the "Head, Shoulders, Knees and Toes: Healthy Aging Symposium" to be held at the Neighborhood Place on August 30.
